BACKGROUND: The Landmarks Advisory Committee has spearheaded a project to protect the historical Rye Mile Markers. On July 14, 2012 Mile Marker 26 was removed from the wall of Christ's Church due to severe deterioration. According to a report by George Wheeler, Director of Conservation, Historic Preservation Program, Columbia University: "The Rye mile marker is severely deteriorated in several including scaling, flaking and spalling traces of active and dormant biological growth. There is no legible inscription remaining on the surface and, as described above many areas where the surface is unstable and shows movement under applied pressure."

Mile Marker 26 has been restored and is ready for display indoors according to the recommendation of the conservationist. The Mile Marker will be displayed under the portrait of Mayor John Morehead who was instrumental in recognizing their importance and placement. They hold historical value in their relationship to the first Post Office, their significance in travel as they marked mileage along Boston Post Road, and their significance in the history of Rye.

1. <u>Pledge of Allegiance</u>

Mayor Sack called the meeting to order and invited the Council to join in the Pledge of Allegiance.

2. <u>Roll Call</u>

Mayor Sack asked the City Clerk to call the roll; a quorum was present to conduct official city business.

3. <u>General Announcements by the Council</u>

Announcements were made regarding various events and activities that may be of interest to residents.

4. <u>Consideration of the election of the Chiefs of the Rye Fire Department</u>

Mayor Sack made a motion, seconded by Councilman Mecca and unanimously carried, to approve the election of Michael Billington as 1st Assistant Chief and Michael Taylor as 2nd Assistant Chief at the Annual Fire Department meeting held on April 9, 2015.

Councilwoman Brett made a motion, seconded by Councilman McCartney and unanimously carried to approve the informal minutes of the Joint Meeting of the City Council and Board of Education held on April 11, 2015.

6. <u>Issues Update/Old Business</u>

Councilwoman Brett reported on the following topics:

<u>Dogs</u> – 109 off-leash permits have been issued to date and a police officer will be a presence in the park as of April 28^{th} to check licenses and issue summonses to those having their dogs off leash after 9:00 a.m.

<u>Planning Commission application for rezoning 120 Old Post Road</u> – The Planning Commission is preparing a recommendation for the Council on the request for rezoning of the site for senior housing. The Commission is still evaluating density issues.

<u>Mile Markers</u> – The Landmarks Committee is ready to unveil Mile Marker #26 at the next City Council meeting. The marker was removed from the wall outside Christ's Church.

Councilwoman Killian reported on the following topics:

<u>Traffic and Pedestrian Safety Committee</u> – The Committee discussed the intersections around the area of 120 Old Post Road and City Engineer Ryan Coyne has suggested a solution of a rotary on Playland Parkway between I95 and the overpass. They have also discussed the intersection at Sonn Drive and sidewalks on Forest Avenue.

<u>Sustainability Committee</u> – The Committee met with the Conservation Commission Advisory Council and they would like Rye to become a Climate Smart Community.

7. <u>Report of the Rye Playland Advisory Committee with regard to the Westchester County</u> proposal for Standard Amusements to take over management of Playland

Steven Vasko, Chair of the Rye Playland Advisory Committee ("the Committee") reported on the proposed agreement between Westchester County and Standard Amusements ("Standard") to take over management of Playland. He said there is a short timeframe of 60 days for the review period for the proposed contract, so it is important to collect comments and feedback as quickly as possible. The Parks Committee will be meeting this week and they will be speaking with Standard. He added that he has personally spoken with members of the Standard team and feels that it is important to them to have the people who live around the park and Rye in general be happy with them. Mr. Vasko said that the overriding feeling expressed by the community at the meeting of the Committee is that the proposed contract is vague with respect to many important areas:

- Fields
- Waterpark
- Utility taxes
- Safety and emergency services
- Heights of new rides
- Possible marina
- How new facilities and increased attendance will impact the neighborhood
- How maintenance services will be provided to the Edith Reed Sanctuary
- Will suggestions from the Biederman Report be included in the final plan.

Mayor Sack said that a group from the Council will probably meet with Standard next week and will be focused on the language of the agreement. He added that the City has nothing to act on until there is a tangible proposal and reiterated that the City believes it has right of approval of any projects. The Mayor said the more important tax issue is whether certain uses at Playland can be taxed.

8. <u>Residents may be heard on the Westchester County proposal for Playland</u>

Ken Ball, 14 Adelaide Street, said he is opposed to the proposed playing fields because they will extend farther into the parking lot. He suggested it would make more sense to refurbish the existing fields.

9. <u>Continuation of Public Hearing to amend local law Chapter 165 "Signs", of the Rye City</u> <u>Code by adding Section §165-10, "Regulation of banners", to establish regulations for</u> <u>banners on utility poles on City property</u>

Mayor Sack made a motion, seconded by Councilwoman Brett and unanimously carried to close the public hearing. No action was taken on the proposed local law.

10. Public Hearing to amend local law Chapter 177 "Taxation", Article XII, "Exemption for Historic Districts" by adding Section §177-82, "Historic Districts", to designate portions

of downtown Rye as one historic district to allow property owners to apply for the real property tax exemption

This Agenda item was deferred to the May 8, 2015 City Council meeting.

11. <u>Presentation and discuss of proposed design changes for sidewalk and street</u> <u>improvements in the Central Business District</u>

City Planner Christian Miller made a presentation regarding plans for the capital project improvements for the intersection of Smith Street and Purchase Street and Elm Place and Purchase Street that were approved by voter referendum in 2012. Staff is seeking consensus from the Council that they are comfortable with the proposed design. The plan is consistent with what was done at Locust Avenue and Purchase Street. Stop signs will be maintained; curb extensions will be added to make pedestrians more visible; trees will be added to improve aesthetics; and more sidewalk space will be added to improve the pedestrian environment. There will be a three way stop at Elm Place and Purchase Street. At Smith and Purchase Streets there will only be a stop sign at Smith Street but a raised intersection will be utilized at that location for traffic calming. The restriction on left turns at Elm Place will be removed. Mr. Miller said the proposed improvements should be considered "70 year improvements" and said that construction which may last for up to four months will cause disruption in the Central Business District. The design is being done "in house" in order to control the design process. Funding the project through the use of debt was approved in the bond referendum but the Council could choose to fund the project without the use of debt which is counted against the tax cap. Mr. Miller was asked to keep the Council updated as the project moves along.

12. <u>Residents may be heard on matters for Council consideration that do not appeal on the agenda</u>.

Mack Cunningham spoke about the Starwood Capital plan for redevelopment of the old United Hospital site and said it was important for the public to know the scope of the project and how it will affect areas of Rye located near the site. Mayor Sack asked for an update on the project for the next meeting. Mr. Cunningham also noted and that the US Alliance site on Midland Avenue had been sold and asked what would happen if the use changed.

13. <u>Resolution to appoint an Interim City Manager effective May 1, 2015</u>

Mayor Sack announced that there was no agreement yet so a special Council meeting will be held on Wednesday, April 29, 2015 at 3:15 p.m. to approve an agreement for an Interim City Manager. He noted that Thursday, April 30th would be the last day on the job for retiring City Manager Frank Culross.

Former Mayor John Carey called the hiring of Mr. Culross his greatest achievement as Mayor.

14. <u>Consideration of proposed revision of the Rules and Regulations of the City of Rye</u> Police Department: General Order #118.1, "Department Records"

BACKGROUND: The City Council amended Chapter 177, "Taxation" of the City of Rye Code at their December 18, 2013 City Council meeting by adding, Article XII "Exemption for Historic Districts" to provide tax exemptions for improvements to historic properties. To qualify for the tax exemption a property must lie within a historic district. The Landmarks Advisory Committee requests approval to designate portions of downtown Rye (B-2 zone plus portions of contiguous B-1 zones) as one historic district. The Council is asked to hold a Public Hearing to amend the Chapter 177 to include this change.

See attached request from the Landmarks Advisory Committee and draft Local Law.

CITY OF RYE LOCAL LAW NO. 2015

A local law to amend Chapter 177 "Taxation" Article XII "Exemption for Historic Districts" of the Code of the City of Rye by adding a new Section 177-82 "Designation of **Historic Districts'' as follows:**

Be it enacted by the City Council of the City of Rye as follows:

Chapter 177 Taxation; Article XII Exemption for Section 1: "Historic Districts"

§ 177-82. **Designation of Historic Districts.**

A. The designated Historic District shall be set forth in this section by block and lot number, street designation, and if appropriate, by local designation.

(1) Central Business District: portions of downtown Rye located in the B-2 zone and portions of contiguous B-1 zones as designated on the accompanying map as one historic district.

Severability. Section 2:

If any clause, sentence, paragraph, section or part of any section of this title shall be adjudged by any court of competent jurisdiction to be invalid, such judgment shall not affect, impair or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, section or part thereof directly involved in the controversy and in which such judgment shall have been rendered.

Section 3: Effective date.

This local law will take effect immediately on filing in the office of the Secretary of State.



Proposed Historic District for the City of Rye Central Business Area

Prepared by the Landmarks Advisory Committee

November, 2014

Background

In December 18, 2013 the Rye City Council enacted local law 4-2013, a real property tax exemption for historic property, the terms of which are described in Article 177 XII of the City Code. The legislative intent of the law is to provide owners of properties with historical significance a concrete incentive to restore or improve those properties while maintaining the character of the original construction.

In order to qualify for the tax exemption, a property must lie within a historic district. The Landmarks Advisory Committee requests approval to designate portions of downtown Rye (B-2 zone plus portions of contiguous B-1 zones as designated on the accompanying map) as one historic district.

Chapter 177. TAXATION

Article XII. Exemption for Historic Districts

[Adopted 12-18-2013 by L.L. No. 4-2013]

§ 177-78. Legislative intent; review process; historic determination; rights of property owner.

- A. This real property tax exemption for historic property is being enacted in order to achieve the following goals: to increase incentives for property owners in historic districts to invest in the upkeep and rehabilitation of properties; to provide an incentive for the restoration and rehabilitation of commercial structures which qualify as landmarks in order to provide financial advantages, not available elsewhere in the country at this time, which may help to attract and retain businesses in the City of Rye; to assist homeowners who are interested in restoring their own properties but may not be able to afford to do so when faced with potential increases in taxation as the result of alterations which would qualify for this exemption; and to provide a concrete benefit for restoring or improving historically or architecturally significant properties which are subject to the regulations of Chapter **117**, Landmarks Preservation.
- B. The City of Rye real property tax exemption is intended to apply to alterations or rehabilitations of historic property as authorized pursuant to §§ 96-a and 119-aa through 119-dd of the General Municipal Law and § 444-a of the Real Property Tax Law and all other powers granted to the City of Rye to provide such exemptions.
- C. This article is intended to create a real property tax exemption that preserves or increases the historic character of real property located within the City of Rye.

§ 177-79. Definitions.

For the purposes of this article, the following words and phrases shall have the following meanings.

ALTERATION

Only exterior work on a building that requires a building permit or demolition permit.

CERTIFICATE OF APPROPRIATENESS

A certificate issued by the Board of Architectural Review authorizing a material change of appearance of a Protected Site or Structure or within a district, subject to other applicable permit requirements.

DEMOLITION

The destruction of the exterior of a building, in whole or in part, whether or not the foundation is also destroyed pursuant to the requirements of a duly issued demolition permit.

HISTORIC BUILDING

Any building that the Landmarks Advisory Committee has determined to be of a historic nature consistent with the criteria outlined in Chapter **117** of the Rye City Code and is located within an historic district. A historic building does not have to be designated as a Protected Site or Structure.

LANDMARK

Any parcel or building or structure designated as a Protected Site or Structure not located in a Preservation District, which nonetheless meets one or more of the criteria enumerated in § **117-5** and is designated as a Protected Site or Structure pursuant to § **117-5E**.

§ 177-80. Amount of exemption granted; qualifying criteria.

Real property within the City of Rye altered or rehabilitated subsequent to the effective date of this article shall be exempt from City real property and special ad valorem levies, subject to and in accordance with the schedule set forth in § 177-8A and conditions outlined in § **177-80B** and **C**.

A. Historic property which shall be defined hereafter shall be exempt from taxation to the extent of any increase in value attributable to such alteration or rehabilitation pursuant to the following schedule:

- B. No such exemption shall be granted for such alterations or rehabilitation unless all of the following criteria are met.
 - (1) Such property must be "historic," which means that:
 - (a) The property has been designated as a landmark pursuant to Chapter **117** of the Rye City Code; or
 - (b) The structure has been found to meet the criteria of being an historic building by the Landmarks Advisory Committee and is part of a historic district.
 - (2) Alterations or rehabilitation are consistent with the character of the historic building.
 - (3) Such alterations or rehabilitation or reconstruction of the historic building are approved by the Landmarks Advisory Committee and the Board of Architectural Review prior to the commencement of work and a certificate of appropriateness issued.
 - (4) The alterations or rehabilitation or reconstruction must otherwise result in an increase in the assessed valuation of the real property.
 - (5) Alterations or rehabilitation or reconstruction are commenced subsequent to the effective date of this article.
- C. In the event a historic building is substantially demolished due to fire or other act of nature not caused by the property owner, the reconstruction of such building consistent with its historic character as reviewed and approved by the Board of Architectural Review shall qualify for the partial tax exemption, but in no event shall the assessment for the taxes to be paid be less than the assessment that existed prior to the substantial demolition.

§ 177-81. Application for exemption; approval.

- A. The exemption may be granted only upon application of the owner or owners of such historic building on a form prescribed by the New York State Office of Real Property Services, or any successor agency.
- B. The application must be filed with the Assessor on or before the appropriate taxable

status date.

- C. The exemption shall be granted where the Assessor is satisfied that the applicant is entitled to an exemption pursuant to this section.




Proposed Historic District Boundary B-2 Central Business District Property Boundary (Approx.)⁻ Last Revised: 12/2/14

DE PAUW MUNICIPAL BOAT BASIN COMMISSION NOMINATION PROCEDURES, ELECTIONS AND TERMS

Section 1. Commission; Appointment

(a) There will be a De Pauw Municipal Boat Basin Commission to consist of five resident members who have a permit to moor a boat at the facility. The members will be appointed by the City Council after election by the resident and non-resident permit-holders of the Boat Basin. The members of the Commission will elect a Chairman each year from their group. The Chairman may serve only three terms in succession.

(b) The term of the members will be two years, commencing on January 1. There is no limit to the number of terms a member may serve.

(c) Vacancies will be filled within 45 days by appointment of the City Council until the next election, at which time the unexpired term will be filled by the candidate elected with the least number of votes.

Section 2. Nominating Committee

(a) The City Council will designate a three-member nominating committee to consist of one current Commission member who is not standing for re-election at that time, one permit-holder recommended by the Commission and one person elected to the nominating committee during the previous year's election.

(b) The nominating committee will not be restricted in the maximum number of people it can name and it must name at least two more candidates than there are open seats.

(c) The Chair shall be appointed by the City Council.

(d) The nominating committee may not name any of its members as candidates.

(e) Other permit-holders who wish to serve on the Commission and who are not named by the nominating committee may secure a place on the ballot by obtaining signatures of 25 qualified voting permit-holders on a designating petition.

Section 3. Election

(a) Voting will take place by mail over a three-week period.

(b) One ballot will be allowed per mooring permit.

(c) Resident and non-resident permit-holders will have equal voting rights.

(d) Ballots will be tabulated by the City Clerk and the results will be prominently posted at the Boat Basin.

(e) The City Clerk will submit a list of the elected nominees to the City Council by September 10.
